The competition will take place on August 25, 2021 in the area of Incheba, Bratislava. The competition will be evaluated on August 25, 2021 in the forenoon and results will be announced during the reception on the occasion of opening of the exhibition.

II. Competition Conditions

The applicant meeting the following conditions can enrol the exhibit for competition:

- The exhibit is enrolled to the competition by an IDEB 2021 exhibitor,
- The exhibit must be enrolled to the competition by July 26th, by delivering the fully filled-in application form to the IDEB 2021 exhibition organiser,
- The exhibit must be available for the jury no later than by August 25, 2021 10:00 a.m. - in the stand of the exhibitor,
- Each of exhibits must be enrolled separate and application form can be attached by further information on the exhibit (booklets, photos, expert opinions, etc.),
- The exhibit can be registered only in one competition category,
- The applicant will pay a registration fee in the amount of €220 without VAT, for every registered exhibit based on payment in advance document (the application form will be registered upon clearing the fee into the exhibition organiser's account)
